Terminology	Description
<b>Benefit year</b>	A benefit year refers to the benefits a member is entitled to during a calendar year, that is to say 1 January to 31 December. This medicine list (formulary) and Chronic Drug Amounts are applicable for 2019 only.
<b>NAPPI code</b>	This is a unique identifier for a given medicine, surgical or consumable product.
